## **Description**

- MirroFlex Structures Perforated/Acoustical Tiles are perforated thermoplastic tiles with high impact resistance, and are available in over 40 patterns for 2'x2' lay in applications. There are matte and gloss finish options in two colors, black or white. They can be used as a decorative product where other acoustical 2'x2' lay in ceiling tiles are typically used.
- MirroFlex Structures Perforated/Acoustical Tiles can easily be cut to size with razor knives or scissors.
- Size (nominal) 2' x 2' x .030" (610 x 610 x .76 mm). This is a dimensional product, so actual thickness varies by pattern.
- Product ships with clear protective film.
